CAP opened the region's only Men's Wellness Center in the heart of the Stark Street Triangle area. The Wellness Center offers a wide range of health screening and wellness programs to gay and bisexual men. Over 400.000 safer sex kits and condoms were distributed and 548 men tested for HIV.

> Housing & Employment

CAP's Housing & Employment Services supported 594 people with HIV and 444 of their family members through CAP's Housing and Employment Services. Over \$380,000 was provided in cash assistance. CAP developed 10 new affordable housing units.



57 amazing, passionate peer volunteers in our Teen to Teen program educated over 5,000 youth on reducing their risk for HIV and other sexually transmitted infections. Nearly 10,000 of our youth-created social marketing materials were distributed.



Statewide Programs

The Oregon AIDS Hotline provided information including risk reduction counseling to 5,053 people from all 36 Oregon counties. The Hotline's comprehensive resource data base went live online this year, making information readily accessible over the Internet.

The Benefits Assistance Program was launched as a new resource this year to assist clients in navigating the complex network of public and private benefits. The program helped over 400 clients statewide to access or maintain benefits critical to promoting their health.
